Textual Information(1)	Disclosure dated February 19, 2026: As per the shareholding pattern for the quarter ending December, 2025 the shareholding of Smt. Sharmila Shetty as one of the promoters of the company was shown to be 11,78,118 equity shares which included the 8,61,918 equity shares which is presently the subject matter of the civil suit being T.S No.41 of 2012 pending before the Ld. Civil Court Jorhat, Assam and also the pending appeal before the Honble Gauhati High Court being FAO No.62 of 2025. The said 861,918 equity shares are also the subject matter of the pending probate petition pending before the Honble High Court at Calcutta and registered as Testamentary Suit No.27/2016 wherein the named executor is Shri. Somnath Chatterjee. This was disclosed in the declaration filed by the Company for the quarter ending December, 2025. However, pursuant to the recent order passed by the Honble Gauhati High Court on January 28, 2026 in IA (Civil) No.3983/2025 arising out of FAO No.62 of 2025 and subsequent order passed on February 5, 2026 by the Honble Supreme Court dismissing the Special Leave Petition (C) No.5070 of 2026 that the HDFC Bank Limited as the depository participant has complied with directions by the Court and reverted the 861918 equity shares of B & A Limited from the demat account of Smt. Sharmila Shetty bearing DPID IN 300476, client no.40436310 to the demat account of late Hemendra Prasad Barooah and Sharmila Shetty bearing DPID IN 301151, client no.26424547 which was the status prior to November 12, 2025. Thus, present shareholding of Smt. Sharmila Shetty is therefore now shown as 3,16,200 equity shares and 8,61,918 equity shares are reflected in the name of Hemendra Prasad Barooah as the first named holder in the depository records bearing DPID IN301151 and client no.26424547 along with Smt. Sharmila Vijay Shetty as the second named holder. The present disclosure is made in compliance with Regulation 31 of the SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015 based on the records of the depository participant.
