Industree Foundation, NSRLM join hands to strengthen women-led bamboo livelihoods

KOHIMA (NAGALAND), JULY 13: Industree Foundation has signed a Memorandum of Understanding (MoU) with the Nagaland State Rural Livelihoods Mission (NSRLM) to promote regenerative, women-led bamboo livelihoods by integrating 30,000 smallholder women farmers into the bamboo value chain across the state. The agreement, signed in Kohima, is part of the Bamboo Sub-Sector Initiative under the DAY-National Rural Livelihoods Mission (NRLM) of the Ministry of Rural Development and aims to strengthen climate-resilient, income-generating rural enterprises.

The partnership will see NSRLM and Industree Foundation collaborate to establish women-led collective enterprises, expand bamboo cultivation on fallow and underutilised land, improve processing capabilities, and strengthen market linkages.

Historic step towards conservation of Assam's threatened birds: Axomor Dusprapya Sorai unveiled

GUWAHATI, JULY 13: In a significant milestone for biodiversity conservation and ornithological literature in Assam, the Assamese book Axomor Dusprapya Sorai (Assam's Rare and Threatened Birds) was officially unveiled on Sunday at the News Live office in Guwahati.

Authored by noted bird experts Firoz Hussain and Kabir Saikia, the book was formally released by eminent ornithologist Dr. Anwaruddin Choudhury, News Live Managing Editor Zair Hussain, and Pranab Talukdar, General Manager of GL Publications, during a function attended by conservationists, journalists, and distinguished guests.

The event, where Kabir Saikia explained the objectives behind the publication, was also attended by Nawaz Ahmed, President of Jorhat Central Club, BJP state leader Sidhanku Ankur Barua, senior journalist Pradip Bora, and several other prominent personalities.

On the same day, Assam's Education Minister and avid bird enthusiast Dr. Ranaj Pegu also unveiled the book

at his office. Besides contributing a congratulatory message, several bird photographs captured by the minister have been featured in the publication. Releasing the book, Dr. Pegu expressed confidence that it would play a transformative role in promoting bird



conservation and raising awareness about Assam's rich avian diversity.

The book is the first comprehensive Assamese-language publication dedicated to the state's threatened and endangered bird species. More than just a field identification guide, it is expected to serve as an important reference document for biodiversity conservation in Assam.

Covering rare and threatened birds found across Assam's forests, wet-

lands, grasslands, riverine habitats, and hill ecosystems, the book provides detailed information on each species, including identification features, habitat, distribution, behaviour, conservation status, and the threats they face. It is richly illustrated with high-quality photographs, making it an invaluable resource for birdwatchers, students, researchers, and nature enthusiasts alike.

The authors said the primary objective of the book is not merely to document bird species but to inspire greater awareness and appreciation for nature and wildlife conservation, particularly among the younger generation.

Speaking at the launch, renowned naturalist Dr. Anwaruddin Choudhury described the publication as a landmark contribution, stating that the release of such a comprehensive and informative book in the Assamese language is especially significant for a biodiversity-rich state like Assam and will greatly support conservation efforts in the years to come.
