Concern grows over proposed closure of historic Dispur Playground

GUWAHATI, JUNE 18: Strong resentment is brewing among residents of the Greater Dispur area over reports that the State Government is considering constructing a parking facility on the historic Dispur Parade Ground, popularly known as the Janata Bhanwar Field, which serves as the only major playground and open recreational space in the locality. Sports enthusiasts, senior citizens, youth organizations and local residents have urged the government to reconsider the proposal, arguing that Guwahati, already struggling with rapid urbanisation, traffic congestion and shrinking open spaces, cannot afford to lose one of its few remaining public playgrounds. The ground, situated between the Assam Secretariat and the Assam Legislative Assembly complex, has for more than five decades functioned as a hub of sporting and recreational activities. Hundreds of children and young athletes use the field daily for football, cricket, athletics and other sports, while senior citizens regularly visit the ground for jogging, walking, yoga and physical exercise. The Assam Jogging Association, a non-profit organisation established in 1995, has been promoting sports and fitness activities at the venue for decades. The association's first president was former Sports Minister Indra Gogoi. With government permission, an office building was established on the premises, and various sporting events, trekking programmes, yoga camps

and coaching activities have since been organised there. A football coaching centre, gymnasium and the City Cricket Coaching Centre also operate from the ground. Residents point out that the playground has historical significance as well. It was established in 1972 during the tenure of former Chief Minister Sarat Chandra Sinha following the shifting of Assam's capital from Shillong to Dispur. The ground was envisioned as a public recreational space for children, youth and senior citizens of the emerging capital city. Expressing concern over the reported proposal, local residents said that Guwahati needs more playgrounds, parks and green spaces rather than fewer. They argue that open spaces act as the "lungs" of a city by improving air quality, reducing urban heat and providing opportunities for physical activity and social interaction. Environmentalists and residents further noted that Guwahati has already lost many age-old trees and green spaces in the name of development over the past several decades. Several large trees, regarded by many citizens as living monuments and silent witnesses to the city's history, have disappeared due to road expansion and infrastructure projects. The loss of such natural assets, they say, has steadily reduced the city's green cover and environmental resilience. "In a city becoming increasingly crowded and congested, every playground and every patch of greenery

matters. Development is necessary, but it should not come at the cost of public spaces that contribute to the physical and mental well-being of citizens," said a senior member of the Assam Jogging Association. Residents have suggested that if additional parking facilities are required for the Secretariat and Assembly complexes, alternative government land available in the vicinity should be explored instead of converting the playground. The Assam Jogging Association, along with sports organisations, coaching centres, youth groups and senior citizens, has submitted a public petition to the Chief Minister seeking reconsideration of the reported proposal. They have also demanded that if the government ultimately decides to utilise the land for any public purpose, it should first develop an alternative modern sports complex in the locality with playgrounds, walking and cycling tracks, gymnasium facilities and office space for existing sports organisations. Many residents believe that preserving the Dispur Parade Ground is not merely about saving a playground but about protecting a vital community asset and an important part of the capital city's social and sporting heritage. As concerns continue to mount, citizens are hoping that the government will engage in consultations with stakeholders and find a solution that balances developmental needs with the preservation of one of Dispur's last major public open spaces.
