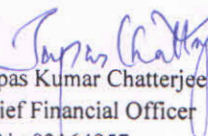

3) Terms and Conditions of transactions with related parties

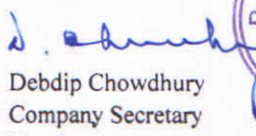
