A member holding more than ten percent of the total share capital of the company carrying voting rights may appoint a single person as proxy and such person shall not act as proxy for any other shareholder.

#### Other instructions on remote e-voting

- (v) The Scrutinizer will make his report of the votes casted in favour or against, if any, to the Chairman of the AGM or a person authorised by him on Saturday, 16th September 2017 and he shall declare the results of the voting forthwith.
